SUMMARY

- The Offer Price has been determined at HK\$1.20 per Offer Share (excluding brokerage of 1%, the SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.20 per Offer Share, the net proceeds from the Global Offering to be received by the Company after deduction of underwriting fees and commission, and estimated expenses payable by the Company in connection with the Global Offering and assuming the Over-allotment Option is not exercised, is estimated to be approximately HK\$70.6 million.
- A total of 16,236 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** for a total of 7,996,582,000 Hong Kong Offer Shares, equivalent to approximately 799.7 times of the total number of 10,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- Due to the very significant over-subscription in the Hong Kong Public Offering, the reallocation procedure as described in the section headed “Structure and conditions of the Global Offering — The Hong Kong Public Offering — Reallocation” in the Prospectus has been applied. A total number of 40,000,000 International Placing Shares have been reallocated from the International Placing to the Hong Kong Public Offering.
